Anti Ragging Committee Annual Report 2023-2024

Anti-Ragging Committee at ASM's College of Commerce, Science & Information Technology has been established under Section vide No.37-3/Legal/AICE/2009 dated 01/07/2009 for Prevention and prohibition of Ragging in technical Institutions. The composition of Anti ragging Committee is as follows:

Objectives:

- The committee will decide and finalize Anti Ragging Regulations for the institution, in accordance with the prevailing regulations of various statutory bodies.
- To conduct Anti Ragging Committee meeting time to time .
- To ensure submission of undertaking in the prescribed format from the candidate concerned on anti-ragging at the time of admission.
- To arrange to send letters to parents, and guardians of the students at the beginning of the academic year for the creation of awareness.
- To suggest measures to tighten vigil against any act which constitutes ragging?
- Measures for prevention of ragging so that fresher's, senior students, and every members of the institute are made aware of the measures.
- Measures for prohibition of ragging to eliminate the scourge of ragging as per the definition given in the relevant regulations, including the formation of the Anti-Ragging Squad, Mentoring Cell on ragging etc. Ensuring that undertakings in the form of Affidavits by students, parents/guardians,
- and staff members of the institutes are taken.
- Ensuring that the actions to be taken are as per the guidelines of the relevant regulations as laid

- To prevent and eliminate incidents of ragging within the college premises and hostels, as well as in the neighbourhood.
- To create a safe and supportive environment for students by strictly enforcing a zero-tolerance policy towards ragging.
- To ensure compliance with the UGC regulations
- To sensitize students about the harmful effects of ragging and the disciplinary actions that will be taken against offenders.
- To promote a culture of respect, empathy, and camaraderie among students.

Functions/Responsibilities:

- Disseminating information on the consequences of ragging through orientation and awareness programs.
- Forming and deploying an anti-ragging squad to regularly monitor the campus, hostels, and neighbourhood.
- Implementing pre-emptive measures to prevent ragging incidents from occurring.
- Investigating complaints related to ragging promptly and impartially.
- Taking appropriate disciplinary actions against individuals found guilty of ragging, which may include expulsion, suspension, or legal action.
- Publicizing the contact information of the committee members for easy reporting of incidents.
- Periodically reviewing and updating the anti-ragging policy to ensure its effectiveness.

Action Taken Report 23-24

- Anti-ragging online form cum affidavit link is circulated among the newly-admitted students in the session 2023-24. Every student is made to sign an elaborate oath, pledging never to indulge in or support any sort of ragging activities in the College. It is also made clear that any ragging activity in the College will be severely penalized using legal actions.
- Multiple Anti-Ragging posters are displayed throughout the College premises to enhance the spread of awareness.
- A detailed orientation program is conducted for the newly admitted students to
 make them aware of the College policies on Anti-Ragging. This includes making
 aware of the Anti-Ragging helpline number and the Anti-Ragging reporting forms.
 The details of the anti-ragging committee are given on the website for quick contact
 in case of any incident of ragging.
- For good monitoring, small group of students were made, for each group one staff member was assigned for interacting individually with each member of group on daily basis to ascertain the problems difficulties if any faced by the students in the college.

- Anti Ragging forms have been filled by all students .
- There is not a single complaint will be registered .
